The above listed service provider has been authorized to perform maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear on Liberian flagged vessels for the makes and types of equipment listed in Attachment A to this certificate, subject to the following conditions pending audit of the service provider for compliance with Resolution MSC 402(96):

1. The service provider shall maintain a valid Approved Service Supplier Certificate issued by a class society recognized by the Liberian Administration verifying that the provider meets the requirements of MSC.1/Circular 1206/Rev.1.
2. The service provider must undergo an audit for compliance with Resolution MSC,402(96) not later than June 30, 2020.
3. Service engineers shall have valid Authorization Certificates, issued by the Approved Service Provider or by the equipment manufacturer, which defines their level of qualification and the scope of the certification (e.g., makes and types of equipment).
4. The service provider shall maintain valid manufacturers' authorization certificate for all equipment to be inspected and serviced.

A copy of this short term Document shall be attached to each report of maintenance, thorough examination, operational testing, overhaul and repair of lifeboats, rescue boats, launching appliances and on-load release gear along with copies of the Authorization Certificate for the service engineers who inspected and/or serviced the equipment.

A copy of this Document shall be provided to the vessel's class society and/or Liberian nautical inspectors when requested.

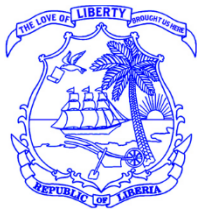
This Authorization Document is valid until the Service Provider undergoes an audit for compliance Reservation MSC 402(96) but not later than June 30, 2020.
